

# Meeting Summary Communique

#### DEWR Local Jobs Program presented by DEWR (Lyzette and Jamie)

- Place-based program ensuring local labour markets work in partnership with local leaders and communities and responding to changing needs of the labour market. Until June 2025.
- Supports tailored approaches to meet local workforce needs
- Three different levels/types of funding are available;
  - Local Initiative Fund small employment activities and community initiatives. Flexible.
  - Local Recovery Fund
  - National Priority Fund six priorities including support for CaLD women through tailored selfemployment; young people through social enterprises; mature age people connect to jobs; regional resilience in response to Net Zero transition; jobs to align with skills of people seeking work; and supporting First Nations peoples in employment options. Funding between \$200,000 to \$1 million through the procurement process. Not exclusive to Workforce Australia participants.
- Employment Facilitators (EF) in 51 Employment Regions. EFs have a more collaborative focus to connect with employers, organisations and peak bodies to challenge and support hiring processes to attract and retain workers. Their work extends beyond Workforce Australia.

### Job Expo – Sydney Greater West EF, CaLD and Migrant Employment Working Group and Employment Accelerator

- DEWR supported service providers to connect and prepare clients with employers.
- The event (with SSI support) brought together local employers, support services (TAFE, ACU, Services Australia, Programs in Workforce Australia), community organisations, interpreter services and 200+ attendees (160 unemployed for more than 12 months).
  - Most attendees had work experience and qualifications, and some were highly skilled (i.e., doctors, and engineers).
- Event registration was made public but attendees who were with Workforce Australia were able to get PBAS for participation.

## **DISCUSSION: Skills Recognition**

- Skilled doctors, engineers, accountants, nurses, social workers etc finding hard to get qualifications and experience recognised or internship to demonstrate skills.
  - DEWR (through EFs) can support employers (with capacity) to assess career pathways and hiring practices to better get skilled workers towards working at a level that matches their qualifications and experience.
- Qualification recognition processes for medical doctors are costly is DEWR working with AMA? Lyzette (DWER) taking question on notice, noting Employer Liaison Officers (DEWR) may be working in this area.



#### DISCUSSION: Advocacy around English-language requirement testing for workers

- SETS provider example of a successful partnership with a university for education and qualifications for refugee nurses.
- Language tests like the PTE (nurses) have potential AI bias on accents. Language tests in general (e.g. IELTS
  for social workers) continue to be a major barrier for people with functional English, to get qualified and
  working with their skills.
- Potential opportunity for Community of Practice communications to inform policies regarding Englishlanguage testing and recognition of the barriers that it creates.
